### **VOLUNTEERING ACTION PLAN**

The ACT Volunteering Statement Action Plan 2018-2021 (Action Plan) includes activities for ACT Government Directorates and Volunteering and Contact ACT, aimed at realising the intentions of the ACT Volunteering Statement (2017).

The Action Plan is designed to contribute to:

- More effective engagement and management of volunteers
- More integrated, person-centred and effective support for volunteers and organisations that involve volunteers
- Individual wellbeing, social inclusion and community connectedness
- Higher quality services and activities for the Canberra community, as a result of the contribution of volunteers.

### THE CONVERSATION

The consultation period for the Volunteering Action Plan ran from 5 December 2017 to 18 February 2018. The consultation was conducted in partnership with Volunteering and Contact ACT.

We consulted with Canberrans through engagement tools on YourSay, a face-to-face workshop and social media.

#### WHO ENGAGED

A number of community stakeholders were engaged in the development of the Action Plan, including:

- Volunteers
- Volunteering and Contact ACT
- Community sector organisations that involve volunteers.

Government stakeholders included:

 Minister for Community Services and Social Inclusion

- Volunteer managers coordinating government programs that involve volunteers
- ACT Government directorates.

## Key insights from the community

#### Resources

There's strong support for providing organisations that involve volunteers with access to resources to facilitate effective, safe and sustainable volunteer involvement.

#### Collaboration

Support exists for encouraging collaboration to link people with meaningful volunteering opportunities.
