# **Tuggeranong District**



### Phase 1 of Consultation: Sharing

# On Thursday 24 November 2022, three events were held in Tuggeranong as part of the sharing and learning phase of the PSRR consultation project.

Communication Link hosted 2 pop-up sessions on Thursday 24 November, to share information about the proposed Territory Plan and the draft Tuggeranong District Strategy. The pop-ups provided the community an opportunity to clarify their understanding with guidance from ACT Government representatives.

Following the pop-ups, we hosted a follow up workshop with a video and presentation from representatives at the Environment, Planning and Sustainable Development Directorate on the draft new Territory Plan the draft Tuggeranong District Strategy.

The objectives of the workshop were to:

- 1. Inform interested people about the draft district strategy and the draft new Territory Plan
- 2. Encourage understanding to support participants to give feedback on the new proposed planning system.
- 3. Collect questions and feedback on the draft documents and other elements of the proposed planning system and provide feedback to workshop participants.

## WHAT WE HEARD

Participants were invited to ask clarification questions about the Tuggeranong District Strategy and draft Territory Plan. Areas of question and feedback are summarised below.

# Community inclusivity and sustainability

Community members raised questions about what actions will be taken to make the area more community inclusive and sustainable. They also asked about what community facilities will be available in the future as the population continues to grow.

#### Erindale

Community members asked questions about what is planned for Erindale. They also raised concerns about transport issues and congested areas due to development in Erindale.

#### Playgrounds

Some community members highlighted the need for quality playgrounds over quantity.

#### Transport

Several community members raised concerns about the current public transport issues in Tuggeranong. Highlighting the need for direct bus routes for people in a specific area rather than a Canberra wide one size fits all approach.

### Monaro Highway

Community members raised questions about what public transport is planned along the Monaro Highway into the city and concerns about current rubbish dumping on the highway.

#### **Territory Plan**

There were questions raised about whether there will be an Industry Design Guide as part of the Territory Plan.

#### **Community housing**

Several community members raised the need for improved community housing.

#### **Community facilities**


Community members would like to see the development of inclusive vibrant hubs which include medical centres, libraries and community centres.

#### **Roads**

Some community members asked about widening major roads including Athlon Drive and Drakeford Drive.
