Voluntary assisted dying is when a person gets help to die


when they want to



how they want to.

You can help us make sure that people who want help to die are safe.

What we want to do



We want to help people who are dying to suffer less.

Suffer means you feel lots of pain.



For example, a person who suffers might

• be very upset that they will die



• feel a lot of pain in their body.



We want to make a new law for the ACT.

A law is a rule.



The new law will let some very ill people choose voluntary assisted dying.



Other places in Australia already have such a law.

How other places make it safe to get help to die



In other places in Australia very ill people can only get help to die if 2 doctors say **yes**.



The doctors must have lots of

• experience




• training.



The doctors will check that the people meet all the rules.



Only some very ill people will be allowed to get help to die.




The very ill people **must** write a letter to say that they want to die.

The people **must** have a **witness** when they write the letter.



A witness is someone who

sees what happens



knows the letter is real.



If the very ill person meets all the rules the doctor will

• fill in a form



 get a medicine that helps the person die when they want to.



The person can take the medicine when they are ready to die.

We want to make it easy for people to find information about

• who is allowed to get help to die



how it works



who can help them.



We want to know what other information you think is important.



People could ask their regular doctor for the information they need.

How can we make it easy to find help to die?



We want to make it easy for dying people to find the right **health professionals**.




A health professional cares for your health.

For example

a doctor



a nurse



We want to make sure that health professionals in the ACT

can help dying people



get good support



make good decisions.





Nobody should tell a very ill person what to do.



We could say in the law that the person **must** have

• enough time to think



 a witness who knows the person made their own decision.



We think the witness should be **independent**.

Independent means someone who does not take sides.



You can tell us what you think.

What rules should we make for the medicine?




We could let very ill people decide **how** they want to take the medicine that helps them die.



Some people can take the medicine themselves.



Other people might want a doctor to help them.



We could also let the people decide **when** they are ready to take the medicine.




Some people who have the medicine will

change their mind

• never use it.

After a person dies




When someone dies in the ACT the government can write a **death certificate**.

A death certificate is a legal letter that says someone has died.



The death certificate also says the reason someone has died.



Some families do **not** want the death certificate to say a person got help to die.



Do you think we should let the families decide?


