Why do we need the new law?



Many very ill people **suffer** when they are about to die.

Suffer means you feel lots of pain.




A person who suffers might

• be very upset that they will die



• feel a lot of pain in their body.



We want to help very ill people who are dying to suffer less.

What is the new law about?



The new law is about voluntary assisted dying.

Voluntary assisted dying is when a person gets help to die

when they want to



• how they want to.



The new law will let some very ill people who suffer get help to die.



Other places in Australia already have such a law.

How the new law will work



We want everyone in the ACT to know

what they are allowed to do



• what they are **not** allowed to do.



For example, we want everyone to know

• when a person can get help to die



how a doctor can help



what training the doctor needs.



The law will also say if other **health professionals** are allowed to help.



Health professionals care for your health.
For example, a nurse.

We want to keep people safe



We want to make sure that people who want help to die

• are safe



get good information



• have a choice about what happens.



We want to make sure health professionals do the right thing.



We could ask health professionals to tell us every time they help a dying person.



We want to know what information you think we should get from health professionals.

We want to check that health professionals follow the law



Other places in Australia do many checks on health professionals.



The health professionals **must** send many reports to an **independent agency**.



Independent agency means people who


• do **not** take sides



• check that everyone follows the law.



Some places in Australia check every report.



Other places in Australia only check some of the reports.



Some places in Australia make dying people wait until after each check.



For example, the people **cannot** get the medicine that helps them die unless

• the health professional sends a report



• the independent agency checks the report



 the independent agency says everyone follows the law.



We want to make sure health professionals follow the law.



We also want to make sure dying people get help fast.



You can tell us what checks you think are fair.

If people are not happy with a health professional



We want to know what should happen if

• a very ill person wants help to die





• the health professional says no

and



 the very ill person is **not** happy about the decision.



Other places in Australia say the person can ask someone to look at the decision again.

For example, a court.




You can tell us what rules we should make for people who are **not** happy.

If people break the law



We want to know what should happen if someone does **not** follow the law.



For example, it would be against the law if

• a doctor lies in a report



a person helps someone die who is
 not allowed to help



the person who gets help to die does
 not want to die.




Some places in Australia have a phone number you can call if you think a health professional breaks the law.



We want to know how we should punish people who break the law.

How can we keep the medicine safe?



We want to keep the medicine that helps people die safe from anyone who

• is **not** allowed to have it



wants to break the law.



The people who are allowed to have the medicine should know

• how to keep the medicine safe




- how to handle the medicine
- how to take the medicine



• what to do with medicine that is **not** used.



Some places in Australia have made special rules for the medicine.



For example, some places in Australia say

• the medicine **must** be kept in a locked box



 a doctor can only get the medicine if the independent agency says yes



 a pharmacist who has the medicine must write a report.



A pharmacist works in a pharmacy.



You can tell us what rules we should make to keep the medicine safe.


